**PAYMENT DETAILS:**

**Deposit**

A \$500 deposit is due within fourteen (14) days of the date of signing this agreement to guarantee tee time reservations. Until deposit is received, the booking is in "hold" status with no tee times guaranteed. The remaining balance for golf tee times is due ten (10) days prior to the event date and will be charged to the credit card on file at the non-cash discounted rate if other payment has not been arranged. The total amount in the pricing table below is an estimate. Actual charges posted on the day of the event are the responsibility of the *GROUP*. Account balances are due in full prior to the conclusion of the *EVENT* on the *EVENT* date.

Failure to pay final deposit due or cancelation of the entire reservation or the reduction of the number of players and/or tee times at least ten (10) days prior to the arrival date shall result in forfeiture of deposit and charges for all cancellations. Charges for all tee times are the responsibility of the *GROUP*.
